POSITION SUMMARY:

The MAT (Medication Assisted Treatment) Case Manager provides care coordination and care planning for patients involved in the medication assisted treatment program and individuals incarcerated at the Chippewa Cree Justice Center.

MAJOR DUTIES:

- Ensures quality care, decreased fragmentation of care, integration of medical psychological, developmental, educational, social, and financial needs, enhanced patient self-care, improved health outcomes, and improved quality of life.
- Provide the full range of assessment of needs, planning for care and evaluation for the MAT program and jail-based programs.
- Develop and provide education of MAT processes to support integration of treatment of substance abuse into primary care.
- Coordinate with Chippewa Cree Justice Center and medical team to implement jail-based care and case management to create a timeline and implementation plan for jail-based care.
- Tracks challenges providing quality care to CCJC inmates.
- Analyze problems and developing effective solutions for correction recognizing situations that indicate more significant problems and relates to senior management regarding difficult and complex issues, evaluated by summary of vaccine data and documentation, identified areas of need for quality improvement and education.
- Support MAT provider and team members to provide quality patient care.
- Undertakes additional responsibilities as delegated and directed by the supervisor to support the overall functioning and objectives of the Rocky Boy Health Center, which may include tasks such as assisting with administrative duties, participating in quality improvement initiatives, contributing to team projects, or engaging in professional development activities.
