This position monitors, manages quality improvement and risk management processes, including those supporting compliance, regulatory and/or accreditation standards. Collects, analyzes, and reports on a variety of data to assess the quality and appropriateness of care and treatment of patients and to provide oversight in the allocation and utilization of program resources.

MAJOR DUTIES:

- Performs chemical analysis on various body fluids.
- Performs complete blood count, manual differential, cell estimations, blood cell morphology studies and other hematologic tests.
- Performs urinalysis and chemical urine tests including toxicology testing and interpretation.
- Prepares specimens for shipment of tests not performed.
- Prepares parallel testing and establishes normal range values for evaluation and standardization of new procedures and equipment.
- Maintain satisfactory quality control on all laboratory procedures examinations performed taking independent corrective action whenever results exceed tolerance limits while maintaining quality control records.
- Ability to set up, calibrate, perform functions checks, perform preventive maintenance and troubleshooting instruments used in daily testing.
